In the presence of a third party AMS application, Asset Manager functions as a compliance Add-On module to filter and organize your asset compliance records. It provides additional Metadata fields for asset searches and the ability to multi-reference the same asset when needed for different regulatory purposes. This minimizes the need to store duplicate asset information in numerous locations within your file structure system. Asset Manager can be used to demonstrate compliance with regulations like OSHA, DOT, EPA, PSM, RMP, SPCC, et al. Asset Manager is versatile and user friendly with user configurable tools for asset types, sub-types, status and Metadata.
